Following is a schedule of meetings and deadlines of the Central/Southern Illinois Synod Candidacy Committee. Candidates will want to plan accordingly to ensure paperwork is filed well in advance of committee meetings. All paperwork should be sent to the synod office: cindy.koonce@csis-elca.org

**If you anticipate an endorsement decision at a time other than the fall, please be in communication with your seminary and the Candidacy Committee to allow sufficient time to schedule your interview.

Candidacy Interviews and Meeting – March 10-11, 2017

Candidacy paperwork must be received and in good order by February 13, 2017, for consideration for the March 10-11, 2017, interviews and meeting.

If you are seeking entrance into candidacy, please note that scheduling of the psychological evaluation requires completion of the application with essay, other documents, and an initial interview. The psychological evaluation process takes approximately four months. Please plan ahead so that the psychological report meets the paperwork deadline prior to your entrance interview.

Candidacy Interviews and Meeting - August 4-5, 2017

Candidacy paperwork must be received and in good order by July 10, 2017, for consideration for the August 4-5, 2017, interviews and meeting.

If you are seeking entrance into candidacy, please note that scheduling of the psychological evaluation requires completion of the application with essay, other documents, and an initial interview. The psychological evaluation process takes approximately four months. Please plan ahead so that the psychological report meets the paperwork deadline prior to your entrance interview.
